TERMS AND CONDITIONS

- _____
Initial
1. **Payment.** A \$400 deposit is required to secure the date of your tournament. The deposit will be applied toward your final bill. Full payment is required the day of the event. It is the tournament chairperson's responsibility to collect green fees, cart fees, and food service fees. If the bill is not settled the day of the event, interest may be applied at a rate of 7%.

2. **Players.** All reservations should be based on foursomes and all players are required to ride in carts. Players must acknowledge standard golf course rules and accept responsibility for course or cart damage. Children not listed as players will not be allowed on the golf course, but are welcome to attend functions prior to or following the tournament.

3. **Beverages.** It is strictly forbidden, as a group or individual, to bring any outside beverages onto the premises. EHGC retains the right to dismiss anyone violating this policy and fine the hosting organization \$50 per item. The tournament chairperson and/or hosting organization may be held liable for any damages caused by tournament participants if alcoholic beverages are purchased and consumed.

4. **Catering.** All food and beverage must be purchased through the Eagle Hills' catering department. A confirmation of at least thirty people is required ten days prior to the event for catering services. Buffet items are priced per person and include all set up and service. Prices are subject to an 18% service charge and 6% sales tax. All food service will be scheduled with the catering manager.

5. **Event Confirmation.** A confirmation of players/teams and menu count is required ten days prior to the event. This guaranteed count may not be reduced, but can be increased up to 10%. You will be charged on your guaranteed count or the actual count, whichever is greater.

6. **Property.** All items brought in by the tournament chairperson and/or guests must be removed at the conclusion of the event. Eagle Hills Golf Course is not responsible for any loss or damage to your property during the event.

7. **Cancellation** This agreement may be cancelled upon written notice from the tournament chairperson. In the event the tournament is cancelled prior to ten days before the event, the \$250 deposit will not be refunded. If the event is cancelled less than ten days in advance of the event, the tournament chairperson may be responsible for the anticipated green fee and cart rental fees to be paid as liquidation damages.

8. **Indemnification.** To the extent permitted by law, you agree to protect, indemnify, defend and hold harmless Eagle Hills Golf Course and the owner of the golf course, and their respective employees and agents against all claims, losses or damages to persons or property, governmental charges or fine, and costs (including reasonable attorney fees), arising out of or connected with your function, except those claims arising out of the sole negligence or willful misconduct of the golf course. The parties agree in the event that any dispute arises in any way relating to or arising out of this contract, the prevailing party in any arbitration or court proceeding will be entitled to recover an award of its reasonable attorney's fees and costs.
